# **TERMS AND CONDITIONS**

Duly completed application forms shall be returned with evidence of payment of a non refundable application fee and any of the following (A) International Passport Data Page (B) Valid Driver License (C) National Identity Card (D) Voter's Card.

The submission and acceptance of application form shall not be construed as a guarantee for allocation of the property applied for. Successful applicants shall be contacted through their contact address on the application form.
